SANTA FE SOLID WASTE MANAGEMENT AGENCY AMENDMENT No. 4 SERVICES AGREEMENT ADVANCED CHEMICAL TRANSPORT, INC. (HHW Collection Services - 2016)

This AMENDMENT No. 4 (the "Amendment") to the SERVICES AGREEMENT, dated November 17, 2016 (the "Agreement"), is made and entered between the Santa Fe Solid Waste Management Agency ("Agency") and Advanced Chemical Transport, Inc., d/b/a ACT Enviro, a California corporation ("Contractor"). The Amendment shall be effective as of the date this Amendment is executed by the Agency.

RECITALS

Under the terms of the Agreement, Contractor has agreed to provide collection services of household hazardous waste (HHW) at the Buckman Road Recycling and Transfer Station (RFP '17/16/P).

Pursuant to Article 18, <u>Amendment</u> of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the Agency and Contractor agree as follows:

1. SCOPE OF SERVICES

Article 1, <u>Scope of Services</u> of the Agreement is hereby amended to include the continuation of collection services of HHW at the Buckman Road Recycling and Transfer Station, attached hereto as Exhibit A.

2. **COMPENSATION**

Article 3, <u>Compensation</u> of the Agreement is hereby amended to increase the amount of compensation by a total of One Hundred Fifty Thousand Dollars and No Cents (\$150,000.00) so that Article 3 reads in its entirety as follows:

A. The Agency shall pay to Contractor in full payment for services rendered, a sum not to exceed Four Hundred Fifty Thousand Dollars and No Cents (\$450,000.00), including applicable gross receipts taxes pursuant to the rates and fee schedule set forth in the Scope of Services attached hereto as Exhibit A.

- B. Contractor shall be responsible for payment of gross receipts taxes by the State of New Mexico on the sums payable under this Agreement.
- C. Payment shall be made upon receipt and approval by the Agency of reasonably detailed invoices describing the services performed. Invoices shall be rendered not more than once each month. Compensation shall be paid only for services actually performed.
- D. Detailed invoices containing reimbursement expenses shall be itemized.

3. AGREEMENT IN FULL FORCE

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
