AMENDMENT NO. 1 TO
CONTRACT ON-CALL SERVICES FOR MIDTOWN CAMPUS

AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE CONTRACT ON-CALL SERVICES FOR MIDTOWN CAMPUS dated August 14, 2019 (the "Agreement") between the City of Santa Fe (the "City") and **Steamer, Inc – dba Proscape Landscape Management** (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor, whichever occurs last.

RECITALS:

A. Under the terms of the Agreement, the Contractor shall provide on call service work, including labor and materials.

B. Pursuant to Article 8 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION

Article 3, of the Agreement is amended to add additional compensation in the amount of **\$190,000.00 not including NMGRT** so that Article 3 reads in its entirety as follows:

The City shall pay to the Contractor on a time and materials basis for work pre-approved by an authorized City of Santa Fe Facilities Division representative in an amount that shall not exceed \$250,000.00.

The total compensation under this Agreement shall not exceed **\$250,000.00 – including applicable New Mexico gross receipts tax (8.4375%)**.

2. AGREEMENT IN FULL FORCE.


Except as specifically provided in Amendment No. 1, the Agreement remains and shall remain in full force and effect, in accordance with its terms.




