CITY OF SANTA FE AMENDMENT No. 1 TO PROFESSIONAL SERVICES AGREEMENT ITEM# 18-1297

This AMENDMENT No. 1 (the "Amendment") amends the CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT, dated November 13, 2018 (the "Agreement"),
between the City of Santa Fe (the "City") and Susan B. Cave PhD., P.C. (the "Contractor"). The date
of this Amendment shall be the date when it is executed by the City and the Contractor whichever
occurs last.

RECITALS:

- A. Under the terms of the Agreement, Contractor has agreed to administer written and verbal psychological screenings for the applicants wishing to attend the NM Law Enforcement Academy (NM-LEA) or the Cert by Waiver Class offered by NM-LEA, to sworn police officers serving in designated high stress and high exposure assignments.
- B. Pursuant to Article 13 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3, paragraph A, subparagraph 2) of the Agreement is amended to increase the amount of compensation by a total of two hundred fifty four dollars (\$254.00) for 19/20, so that Article 3, paragraph A reads in its entirety as follows:

- A. The City shall pay to the Contractor in full payment for services rendered; a sum not to exceed thirty thousand, two hundred and fifty four dollars (\$30,254) inclusive of applicable gross receipts taxes.
 - 2) The City shall pay to the Contractor in full payment for services satisfactorily performed

pursuant to the Scope of Work at the rate of one hundred fifty dollars (\$150) per hour for fitness for duty examinations and critical incident debriefing and/or other duties as assigned. Pre-employment/Pre-Academy evaluations shall be rendered at the rate of two hundred seventy-five dollars (\$275) per evaluation, (\$7,754) in FY19/20 as needed. The total amount payable to the Contractor under this Agreement, including gross receipt tax and expenses, shall not exceed (\$7,754) in FY19/20.

2. <u>AGREEMENT IN FULL FORCE.</u>

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
