Food Mobile Partnership Expectations

The Food Depot will:

- Help identify precise parking location of the Food Mobile
- Facilitate all planning and coordination of Food Mobile distributions
- Communicate clearly and in a timely manner, particularly around any changes in scheduling of distributions
- Provide 3-6 Food Depot staff members and 2-6 Food Depot volunteers to run each event
- Provide all related food product and necessary supplies, including flyers and posters
- Clearly outline Food Mobile guidelines and other program operation details
- Provide food assistance without regards to race, color, sex, age, religion, national origin, ancestry, handicap, sexual orientation, and/or veteran status.
- To not impose a charge or require any donation in order for clients to receive food

Community Partners are asked to:

- Assist in identifying precise parking location of the Food Mobile
- Allocate physical space for the Food Mobile at least a half hour before, one and a half hours during, and at least half an hour after each distribution
- Be responsive and communicate clearly and in a timely manner, particularly around scheduling conflicts
- Assist in promoting Food Mobile events, including displaying posters and helping circulate flyers
- Update The Food Depot with any personnel changes and provide current contact information for appropriate staff members
- Not use Food Depot products for fundraisers or any other activities held by the site

Please note, the association between The Food Depot and the Community Partner is voluntary. Either The Food Depot or the Community Partner may terminate this association at any time.
