- 3. By its signature on this Assignment the Sunny505 concurs with this complete assignment Agreement No. 2022-0169-CDD/CW from the Assignor Santa Fe County to the Assignee City of Santa Fe.
- 4. The Assignee assumes and agrees to perform all the remaining and executory obligations of the Assignor under the Agreement and agrees to hold the Assignor harmless from any claim or demand resulting from non-performance by the Assignee.
