BACKGROUND AND SUMMARY:

The contract with Lamar Transit Advertising to manage all aspects of advertising on the exterior of transit buses expires on March 1st, 2025. The contract was originally established by Request for Proposal #23/04/P in 2023. The contract allows for up to four one year extensions. Revenue from the advertising is collected by Lamar and remitted to the City. Lamar has provided compliant services through the term of the agreement.

CITY OF SANTA FE AMENDMENT No. 1 TO TRANSIT PROFESSIONAL SERVICES AGREEMENT ITEM# 24-0076

This AMENDMENT No. 1 (the "Amendment") amends the CITY OF SANTA FE PROFESSIONAL

SERVICES CONTRACT, dated February 13, 2024 (the "Contract"), between the City of Santa Fe (the "City") and

Lamar Transit Advertising. The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS:

A. Under the terms of the Contract, Contractor has agreed to provide the City advertising design, sales,

placement, management, installation, maintenance, and removal.

B. Pursuant to Article 14 of the Contract, and for good and valuable consideration, the receipt and

sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. <u>TERM</u>

Article 4 of the Original Agreement is hereby deleted in its entirety and substituted with the following

Article 4 in its place:

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE CITY. This Agreement shall terminate on March 1, 2026, unless terminated pursuant to paragraph 5 (Termination), or paragraph 6 (Appropriations). The City reserves the right to renew the contract on an annual basis by mutual Agreement not to exceed a total of four (4) years in accordance with NMSA 1978, §§ 13-1-150 through 15

2. <u>CONTRACT IN FULL FORCE</u>

Except as specifically provided in this Amendment, the Contract remains and shall remain in full force and effect, in accordance with its terms.
